The authorization under rule 10 of the Bio-Medical Waste Management Rules, 2016 is hereby renewed for period from **18/09/2024 to 21/04/2027** subject to the fulfillment of terms & conditions incorporated in the authorization letter no. **143/BMW/HO/CECB/2004 Raipur, dated 22/04/2004** and additional conditions are enclosed herewith.

CONDITIONS PERTAINING TO THE BIO-MEDICAL WASTE MANAGEMENT
RULES, 2016

[Authorization for operating a facility for generation, collection, reception, treatment, storage, transport and disposal of bio-medical wastes]

1. Number of authorization **766/HO/BMW/CECB/ATAL NAGAR, RAIPUR.**
2. Reference of Online Application No. **15018963 Dated 16/05/2024.**
3. The authorization granted vide letter no. **143/BMW/HO/CECB/2004 Raipur, dated 22/04/2004** to occupier of facility i.e. **Apollo Hospitals Enterprise Limited (300 Beds), Seepat Road, Lingyadih, Bilaspur, Distt.-Bilaspur (C.G.)** is hereby granted an authorization for a facility for segregation, collection, reception, storage, transport, treatment and disposal of Bio-Medical Waste as per the agreement with **M/s Envirocare International (Chhattisgarh) Balram Talkies Road, Near Gajanand Hospital Nehru Nagar, Bilaspur** for disposal of BMW which has been granted authorization by **C.E.C.B. Raipur (C.G.)**.
4. This renewal of authorization shall be in force for period from **18/09/2024 to 21/04/2027**.
5. This renewal of authorization is subject to the conditions stated below and to such other conditions as may be specified in the rules for the time being in force under the Environment (Protection) Act 1986.

TERMS & CONDITIONS OF AUTHORIZATION

1. The authorization shall comply with the provisions of Environment (Protection) Act, 1986 and the rules made there-under.
2. The occupier shall obtain membership from CBWTFs for Bar Coding and final disposal of their Bio Medical Waste.
3. The authorization or its renewal shall be produced for inspection at the request of an officer authorized by the prescribed authority.
4. The person authorized shall not rent, lend, sell transfer or otherwise transport the Bio-Medical wastes without obtaining prior permission of the prescribed authority.
5. Any unauthorized change in personnel, equipment, or working conditions as mentioned in the application by the person authorized shall constitute a breach of his authorization.
6. It is the duty of the authorized person to take prior permission of the prescribed authority to close down the facility and such other terms and conditions may be stipulated by the prescribed authority.
7. The occupier shall submit an annual report in enclosed form-IV by 30th June every year to concerned Regional Office of the Board.
8. No untreated Bio-Medical waste & shall be kept stored beyond a period of 48 hours. Provided that if for any reason it becomes necessary to store the waste beyond such period, the authorized person must take permission of prescribed authority and take measures to ensure that the waste does not adversely affect human health and the environment.
9. The occupier shall take necessary action for the treatment of effluent generated from the hospital so as to meet the standards prescribed under Water (Prevention and Control of Pollution) Act, 1974. Standard limit is given below :-

pH	:	6.5-9.0
Suspended solid	:	100 mg/l
Oil and grease	:	10 mg/l
BOD	:	30 mg/l
COD	:	250 mg/l
Bio-Assay Test	:	90% survival of fish after 96 hours in 100% effluent

10. The occupier shall renew consent under Water (Prevention and Control of Pollution) Act, 1974 from Chhattisgarh Environment Conservation Board.
11. This authorization is valid for the stated period. Application for renewal of authorization with requisite renewal fees with compliance statement of above conditions shall be submitted within three months before the expiry date. Hospital shall strictly follow the above conditions, any breach/violation of any of the above conditions will attract the legal action under the provision of Environment (protection) Act 1986.
